Manufacturer Supplier to the Industry End User Individual Technical Consultant Academic Emeritus

Manufacturer (Company Membership)

- a. Companies that have a gear, bearing or flexible coupling manufacturing facility that manufacture gears, bearings, gear and/or bearing products, or flexible couplings for sale – separately or as component parts of end-use products. OR b. Companies that design gears, bearings, gear and/or bearing products or flexible couplings for internal use or for sale – separately or as component parts of end-use products.

Dues are based on the total annual sales volume for the previous fiscal year. Total annual sales volume is defined as the **total worldwide sales** (in U.S. dollars) of all gears, bearings, gear and/or bearing products, and flexible couplings whether sold as such, included in end-use products or as replacement parts.

Bearings manufacturers will have an additional 15% of membership dues added to their invoice to support the World Bearing Association activities.

Minimum dues: \$2,200 plus \$480/\$1,000,000 of volume in excess of \$1 million

Maximum dues: \$24,000 (for any sales volume over \$46.4M)

Supplier to the Industry (Associate Membership)

Companies manufacturing and/or selling machinery, raw materials, or services (including inspection, testing, consulting, and sales representation). Dues are based on total worldwide sales attributable to the gear or bearing production industry.

Minimum dues: \$3,200 plus \$480/\$1,000,000 of volume in excess of \$1 million

Maximum dues: \$24,000 (for any sales volume over \$44.3M)

End User (Associate Membership)

Companies that do not manufacture any gears or bearings but use gears or bearings, gear and/or bearing products, and/or flexible couplings as component parts of end-use products.

Dues: \$3,200

Your MPMA membership supports advocacy that advances the mechanical power transmission industry at the federal level. Please note that 1% of dues is attributable to advocacy activities and, per IRS requirements, is not deductible as a business expense.

Membership Category cont.

Technical Consultant

Consultant Membership is restricted to consultants to the gear and/or bearing industry. The individual must be engaged in full-time consulting as a sole proprietor of his/her company. Individuals who are employed either full-time or part-time by a company or corporation are not eligible for Consultant Membership.

Academic

MPMA has a special Academic Membership for educational institutions. Teachers of Engineering or Department Heads may apply for membership. Applicants should submit a letter from the applicant's supervisor, on university letterhead, stating that the applicant is involved in mechanical power transmission education, and, in the supervisor's opinion, the applicant is eligible for membership in the Motion + Power Manufacturers Alliance.

Emeritus

The primary purpose of Emeritus Membership is to keep individuals involved in the association after they have retired from the industry.
